I, the undersigned Participant, intending to be legally bound, hereby, for myself, my family, my heirs, executors, and administrators, forever waive and release any and all claims for damages, known or unknown, that I may have that are related to or arise out of my participation as a pilot, passenger, or otherwise of any water craft, including, but not limited to a boat, canoe, raft or sled, owned by me or not, in connection with the Great Rotary Duck Race (the Event), against the URC, its members, employees, agents, representatives, officials and volunteers working on or near the Event; and all sponsors of the Event and their officers, directors, employees, agents, representatives, successors, and assigns.

**I attest that:** I am physically fit, and have knowledge of and experience with water crafts. I am aware of all safety precautions that must be taken, including, but not limited to, the wearing of approved floatation devices, when participating in this type of Event, and I acknowledge that the Event is inherently dangerous and notwithstanding the dangers, I have voluntarily decided to participate. I assume the risk of injury, death, or property damage that may result from my participation in the Event. I further assume and will pay my own medical and emergency expenses in the event of an accident, illness, or other incapacity regardless of whether I have authorized such expense.
